Florida's Annual Children's Week Honors Child Advocates

Children's Week hosts 2024 Advocacy Dinner and Awards Ceremony that celebrates children and youth champions

TALLAHASSEE, FL – **February 26, 2024** – Last night, state leaders, elected officials, and child and youth advocates gathered for the annual Children's Week's Advocacy Dinner and Awards Ceremony. The highlights of the evening included a keynote from Lieutenant Governor Jeanette Nunez and the announcement of the recipients for the 2024 Chiles Advocate Award, the Impact Advocate Award, and the Youth Advocate Award.

Dr. Phyllis Kalifeh, former president and CEO of the Children's Forum, was honored with the 2024 Chiles Advocate Award. This award, named after former Florida Governor Lawton Chiles and his wife, Rhea, is presented each year to a Floridian who has dedicated extensive time, philanthropic effort, and advocacy on statewide issues affecting the status and well-being of children, youth, and families.

Dr. Kalifeh retired from the Children's Forum after serving as president and CEO for 22 years. She tirelessly advocated for young children, their families, and the early childhood and school-age workforce. Throughout her career, Dr. Kalifeh served in many leadership positions at the local, state, and national levels advocating for sound policies and systems to improve outcomes for children.

The Children's Week Florida Impact Advocate Award recognizes an individual who significantly improves the lives of children throughout our state. James R. Haj, president and CEO of The Children's Trust of Miami-Dade County was named the 2024 Florida Impact Advocate Award recipient.

When Haj joined The Children's Trust in 2016, his investments in programs and services for children and families in Miami-Dade County rose to their highest levels. He has led his team through unprecedented challenges posed by the coronavirus pandemic, including expanding funding for



emergency assistance programs, strengthening neighborhood supports, and serving as an essential voice for children and families during unprecedented hardships.

Lastly, we are pleased to announce Maurits Acosta as the 2024 Youth Advocate Award recipient. The Youth Advocate Award honors youth who have initiated or diligently worked on behalf of positive change in support of programs or policies that benefit children and families through their school, community, or even at the statewide level. Acosta, a junior at Hialeah-Miami Lakes Sr. High School, finds true passion in service to others. He started a program named Virtutem Populo that encourages youth participation in government and their communities. Through Acosta's efforts, Virtutem Populo has impacted over 3,000 students and raised more than \$40,000 for civic education programs.

"Each year, we gather to celebrate individuals making a positive impact on the lives of Florida's children to recognize the difference they make in the future of Florida," said Erin Smeltzer, president and CEO of the Children's Forum. "Dr. Kalifeh, James Haj, and Maurits Acosta have demonstrated an exceptional commitment to advocating for the improvement of Florida's future generation. I applaud them and everyone who joined us tonight to ensure every child has the opportunity to reach their fullest potential."
